

## YMCA 'Spring Reset Challenge' - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'Spring Reset Challenge' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at South Gippsland Splash and Warragul Leisure Centre. (**Participating Centres**) between the dates of 5 October 2026 to 29 November 2026 (**Promotion Period**).
- d. To be eligible for the Promotion, participants must:
  1. Be an existing Health and Wellness member at a relevant Participating Centre during the Promotion Period
  2. Be aged 18 years or over; and
  3. Comply with these Terms and Conditions.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

### 2. COMPETITION TERMS

- a. If you meet the criteria set out in clause 1(d), you will be eligible for a chance to win the prizes outlined in these terms.
  1. Collect a Spring Reset challenge card from Reception;
  2. Complete 10 visits to their Participating Centre between 5 October 2026 and 29 November 2026, with each visit recorded by Reception staff. Only one visit can be counted per day, regardless of how many classes, sessions or activities are completed during that visit;
  3. Entries are only eligible once a Challenge Card has been fully completed. There is no limit to the number of Challenge Cards an individual may complete;
  4. Return their completed challenge card to Reception by 6 December 2026;

5. YMCA reserves the right to validate all entries prior to awarding prizes.

- b. Entries received after 6 December 2026 will not be accepted.
- c. The Promotion is only available at Participating Centres.
- d. Employees of YMCA and their immediate families are not eligible.

### 3. PRIZES

- a. **Major Prizes:** Three winners from each Participating Centre will be selected at random from all eligible entries received during the Promotion Period.

- a 1<sup>st</sup> prize – 12 months free membership
  - b 2<sup>nd</sup> prize – 6 months free membership
